Unless otherwise specified, it is understood that any and all rights to prints, digital files, uploaded images, albums, CD or DVD media, thereof shall remain the property of *Gauthier Photography* until all invoices are paid in full. *Gauthier Photography* reserves the right to display any photographs made in conjunction with this wedding as samples of its work for the purposes of advertising, publication, instruction and/or professional competition.

2. If *Gauthier Photography* cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then *Gauthier Photography* will return all fees to the Client(s) but shall have no further liability with

respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in transit, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of *Gauthier Photography*. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re shoot and limits Gauthier Photography liability to the amount paid under this contract. (*Gauthier Photography will try to find a suitable replacement photographer in the unlikely event that we are unable to attend your wedding*)

3. On signing of this agreement by both parties, and the receipt of the deposit in the amount of \$\_\_\_\_\_, Gauthier Photography will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes canceled for any reason.

4. The service fee is \$\_\_\_\_\_ and includes \_\_\_\_\_ hours of photography. A deposit of 50% (\$\_\_\_\_\_) is due at the signing of this agreement, with a further payment of the remaining 50% (\$\_\_\_\_\_) due two weeks prior to the date of the wedding (\_\_\_\_\_) all necessary expenses (unless otherwise specified) such as parking, travel outside of the Vancouver area, time overages, taxi, hotel charges, etc., to be paid in full before the wedding photographs and/or digital files are presented/shipped after the wedding. No rights are granted until payment is made in full. The deposit is non refundable in case of cancellation or date change by client. Gauthier Photography reserves the right to refuse services, including photography of the wedding, if all payments are not made in full by the above agreed upon dates. In this event the deposit would not be refundable. It is the responsibility of the booking client to remember and send payment by the due date (post-dated cheques may be sent at any time before the due date to insure payment is made on time).

I / we, the undersigned Contracting Party, hereby warrant that I am / we are competent to contract in my / our own name(s). I / we confirm that I / we have read the herein agreement prior to its execution and I / we are fully familiar with the contents thereof. This agreement shall be binding upon us and our heirs, legal representatives and assigns. And, we certify that we have received a complete copy of this agreement with all blank lines completed
